DIVISION OF RESEARCH AND COLLECTIONS: THE SCIENTIFIC STAFF WORKING IN THE DIVISION OF R&C ADDED 30 NATURAL HISTORY SPECIMENS TO THE MORE THAN 5 MILLION SPECIMENS AND ARTIFACTS HOUSED IN OUR COLLECTIONS, HOSTED 80 VISITING RESEARCH SCIENTISTS, HOSTED MORE THAN 92 MUSEUM VISITORS ON BEHIND THE SCENES TOURS OF THE COLLECTIONS AND LABORATORIES, AND RESPONDED TO MORE THAN 532 REQUESTS FOR EXPERTISE THAT RANGED FROM SPECIMEN IDENTIFICATION TO ADVICE ON ANIMALS IN THEIR BACKYARD. THE STAFF PUBLISHED 5 SCIENTIFIC DOCUMENTS IN REPORT FORMAT OR IN PEER-REVIEWED JOURNALS.
